Northamptonshire Police call for the Review of the Premises Licence for Les Olives under the Licensing Objective of the Prevention of Crime and Disorder. This Review relates to illegal workers being discovered on the premises. The a collegion to review relate sto the recovered treatment objects Please provide as much information as possible to support the application (please read guidance note 3)

On the 12th of December 2019 at approximately 07:00pm, Immigration Officers executed a warrant at Les Olives, the premises was open and trading at the time.

Two immigration offenders were discovered at the premises working in the kitchen area.

An Albanian male who admitted to having no visa and entered the UK in the back of a lorry three years earlier was detained.

A female who had entered the UK legally in September 2019 from Malaysia for six months as a visitor, one of the conditions of her permitted entry was that she could not undertake any form of work during her time in the UK was detained.

All employers have a duty to prevent illegal working and are required to undertake preemployment immigration checks on all staff they wish to employ to ensure that they have the right to work in the UK.

Northamptonshire Police and the Immigration Service would consider that these individuals are being exploited as no employment protection can be afforded to the individuals. It is also considered that employing illegal workers is defrauding the revenue and the business owners are committing immigration offences.

When making this application Northamptonshire Police have consulted the statutory section 182 Guidance that accompanies the Licensing Act 2003, specifically paragraphs 11.24 to 11.28 which relates to Reviews in connection with crime.

Northamptonshire Police would ask the Licensing Sub-Committee to consider revoking the Premises Licence, a lesser sanction would be insufficient to act as a deterrent.

R (Bassetlaw District Council) v Worksop Magistrates Court outlines the case that the action(s) taken by the Licensing Committee can be punitive. Northamptonshire Police ask the Licensing Committee to consider Revocation of this particular Premises Licence in the interests of the wider community for reasons detailed in the above case, who are involved or considering engaging in this illegal activity.
