REVIEW OF PREMISES LICENCE Alcohol & Gambling Licensing Sub-Committee Wednesday 2nd April 2020

1.0 Purpose of Report

1.1 To consider a request from Northamptonshire Police for the Review of the Premises Licence for Les Olives, 18A & 18B Sheep Street, Northampton (each of which are separately licensed).

2.0 Summary

- 2.1 The review application was received on the 13th February 2020 and submitted in accordance with licensing objective(s) for;
 - The Prevention of Crime and Disorder
- 2.2 The current licence holder and designated premises supervisor for each licence is Alex Sefolli.

3.0 Consultations/Representations

- 3.1 When a request for the review of a premises licence or club premises certificate is received, the licensing authority must display a notice at or near the premises, and on the council's website. This gives responsible authorities and any other interested parties a 28-day period during which they may make representations in relation to the review application. It is the responsibility of the applicant to serve a copy of the review application onto the licence holder and the responsible authorities.
- 3.2 The local authority displayed the obligatory notice on the 14th February 2020.
- 3.3 During the 28 day period representations were received from the following responsible authorities and interested parties.

6.0 History of Premises & Licence Holder

6.1 Licence records show that 18A (Ground Floor) Sheep Street was first issued licence number PL0661 in May 2008 and 18B (First Floor) was first issued licence number PL0572 in February 2006.

Alex Sefolli applied to transfer the licence for 18A (Ground Floor) in November 2012 and subsequently applied to transfer 18B Sheep Street in September 2009.

At some point since 2012 both 18A and 18B merged into one establishment known as Les Olives. To date there has not been a variation application submitted to request that the licences are merged.

7.0 Options

- 7.1 At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
 - a. the prevention of crime and disorder;
 - b. public safety;
 - c. the prevention of public nuisance; and,
 - d. the protection of children from harm.

The steps the Sub-Committee can take are to:

- a. to modify the conditions of the licence;
- b. to exclude a licensable activity from the licence;
- c. to remove the designated premises supervisor;
- d. to suspend the licence for a period not exceeding 3 months; and/or,
- e. to revoke the licence.

For the purpose of a. a condition is modified if any of them are altered or omitted or if a new condition is added.

8.0 Policy Considerations


Paragraphs 11.16 to 11.28 highlights the elements of the Guidance that are most relevant with respect to this application. This is not exhaustive, and guidance should be considered fully prior to making decisions with respect to applications.

9.0 Committee

- 9.1 Each application must be considered on its own merits and any conditions attached to licences and certificates must be tailored to the individual style and characteristics of the premises and events concerned. This is essential to avoid the imposition of disproportionate and overly burdensome conditions on premises where there is no need for such conditions. Standardised conditions should be avoided and indeed, may be unlawful where they cannot be shown to be necessary for the promotion of the licensing objectives in any individual case.
- 9.2 Due to the measures in place to protect the public from the risk of spread of the Coronavirus it is intended that this hearing take place through a conference telephone call between members of the Licensing Sub-committee and officers. In this respect the Sub-committee may wish to consider their powers to hold the meeting in private meaning that it is not necessary for the parties to gather in a room and compromise their health.
- **9.3** Further, in order to ensure that the parties do have the opportunity to exercise their right to a hearing and present their case to members, the Sub-committee may wish to consider its power to adjourn this application to a future date at which time a full hearing may take place.

On the 12th of December 2019 at approximately 07:00pm, Immigration Officers executed a warrant at Les Olives, the premises was open and trading at the time.

Two immigration offenders were discovered at the premises working in the kitchen area.

An Albanian male who admitted to having no visa and entered the UK in the back of a lorry three years earlier was detained.

A female who had entered the UK legally in September 2019 from Malaysia for six months as a visitor, one of the conditions of her permitted entry was that she could not undertake any form of work during her time in the UK was detained.

All employers have a duty to prevent illegal working and are required to undertake preemployment immigration checks on all staff they wish to employ to ensure that they have the right to work in the UK.

Northamptonshire Police and the Immigration Service would consider that these individuals are being exploited as no employment protection can be afforded to the individuals. It is also considered that employing illegal workers is defrauding the revenue and the business owners are committing immigration offences.

When making this application Northamptonshire Police have consulted the statutory section 182 Guidance that accompanies the Licensing Act 2003, specifically paragraphs 11.24 to 11.28 which relates to Reviews in connection with crime.

Northamptonshire Police would ask the Licensing Sub-Committee to consider revoking the Premises Licence, a lesser sanction would be insufficient to act as a deterrent.

R (Bassetlaw District Council) v Worksop Magistrates Court outlines the case that the action(s) taken by the Licensing Committee can be punitive. ANNEX 1 - MANDATORY CONDITIONS

Mandatory conditions where licence authorises supply of alcohol

- (1) No supply of alcohol may be made under the premises licence -
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Licensing Objectives

Below are the additional steps that you have agreed to undertake to promote the four Licensing Objectives and which form a part of the operating schedule for these premises: -

Prevention of Crime & Disorder - CCTV will be installed and tapes kept for reviewing if needed.

Public Safety - Persons drinking will be monitored. Fire exit and escape routes will be clearly marked and where required help will be given to disabled etc.

Prevention of Public Nuisance - Ensure all noise is kept to a minimum. Deliveries in normal hours and security lightly on our premises and not intruding on others.

Protection of Children from Harm - Check I.D when requesting drinks and use Check 21 scheme. Children only allowed in the restaurant area and not in the bar.

ADDITIONAL MANDATORY CONDITIONS.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 6th April 2010

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carrries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the perod in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in seciton 159 of the Act;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the pruchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
- (i) the outcome of a race, competition or other event or process, or
 - (ii)the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following mandatory conditions are to be applied to the licence stated above in accordance with section 3 (1) of The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010.

The following conditions shall come into force on 1st October 2010

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for

consumption on the premises (other than alcoholic drinks sold or supplied having ben made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

Representation in relation to Review of Premises Licences for 18A Sheep Street, Northampton, NN1 2LU and 18B Sheep Street, Northampton, NN1 2LU

I am writing in relation to the Review of the two Premises Licences at 18A Sheep Street, Northampton, NN1 2LU and 18B Sheep Street, Northampton, NN1 2LU and would like to put forward my representations as an interested party.

My name is an and I am the freeholder of the two above mentioned properties. The properties have been let out by way of a Lease to a third party and whilst I do not have any link or relationship with the business, which is run from the two parties as you will appred ate I do have an interest in the property.

I have let out the properties on a leasehold basis and this has only been possible due to having a Premises Licences in place. In the event that the Premises Licences are revoked, then the value of the property will diminish and potentially lead to an empty property which will become attractive to undesirables congregating around it.

As the landlord of the property, whilst I am not the Premises Licences holder, I do wish to assist all responsible authorities and ensure that the Licencing Objectives are promoted. In this particular case I wish to work with the responsible authorities and ensure that in particular, in this example, the objective of Prevention of Crime and Disorder Is upheld.

Circumstances surrounding the events of 12th December 2019

I have discussed the matter with those who occupy the properties and run the business and have been provided with the following explanations:

- Malaysian female I have been informed that one of the members of staff shares a
 residential property with this individual and she attended the premises to discuss an issue
 with them about the residential property, which they share, from the particular member of
 staff (I think this may be related to an issue with the electricity at their place of residence).
- 2. The Albanian male I am told is one of many who congregate outside the rear of the restaurant along with other rough sleepers. The chef sometimes provides left over rood to these rough sleepers. The above explanations have been provided to me by those who occupy the premises and run the business.

I have also been informed (but cannot verify this) that both of these individuals were released immediately by the Home Office Officers on the same evening. I also understand that to date no further action has been taken in relation to these and the occupant of the premises has not received any sanctions from the Home Office in relation to this.

Intention to Proceed Forward

I am currently in the process of granting a new lease for 18A and 18B Sheep Street to the street into the stre

I have also been assured that the new tenant will imminently either be applying for a new licence or to transfer the current licences and change the DPS to themselves in the first instance, with a view to vary the licences in due course.


At the time of sending this Representation, I am not aware of whether the tenant will be making their applications by themselves or if they will be obtaining specific independent licencing advice in relation to this.

I can confirm that other than a Landlord and Tenant relationship, there is no other link between myself and I can also confirm that there is no relationship, business or otherwise, between the new tenants and Alex Sefolli.

In the unlikely event that the new tenant is not successful, then I would request the Licencing Authority to ensure that the Premises Licences are not revoked and in an effort to work with all the responsible authorities, I am willing to take back control of the property personally and will be willing to consider any conditions to be placed on the Licence providing they are practicable and workable, and take full responsibility for any activities at the property until such a time that a suitable tenant can be found.

I hope that you will put some weight onto my representations and would urge that rather than revoke the Premises Licences, the Licencing Authority either takes no further action, or, imposes conditions which are practicable and workable to ensure that the premises can continue to run as a restaurant and not put the properties at risk of becoming empty and potential anti-social behaviour hot spots.

I am also very concerned that if the Premises Licences are revoked and the property cannot be re-let to another business, then this property will become another empty property not just within the parade of already empty units in Sheep Street, but also within a Town Centre that is already suffering from lack of business occupancy and an already high number of empty units. I do not wish for this property to be added onto that list.
