The Tobacco and Related Products Regs 2016.
Made under Consumer Protection Act 1987
Trades Mark Act 1994

During an inspection of your premises today we found 12 various branded packets of cigarettes and 11 packets of hand rolling tobacco under the front counter of the shop as well as a box of various branded tobacco (cigarettes) by the back door of shop. These products did not have the correct prescribed markings in English or are suspected to be counterfeit. It is an offence to supply or possess for supply tobacco products which have not been labelled as required. You are required only to sell correctly labelled tobacco products.

It is also an offence under the Licensing Act 2003 to possess on licensed premises smuggled goods and as such the Licensing Authority will be informed. Further Action may be taken in this matter.
