I would like to oppose the application from the owner of Bar Cafe Milano of 152 Wellingborough Road, Northampton for the sake of alcohol consumption from 11am until 11pm Monday to Sunday.

I oppose this application as I live in _____ the cafe which is already causing a nuisance to local residents. They have an outside seating area which does not have planning permission and is on land owned by Northampton Borough Council. Most evenings if residents walk up to that area, it is full of cars parked by customers of the cafe on the double yellow lines, there are large groups of males sitting and standing outside smoking and can be quite intimidating for residents when walking past. I know lots of female residents who now avoid walking past the cafe and will often take a longer route when walking to the Wellingborough Road.

The area is noisy and I was very disappointed to see only one small A4 sized sheet of paper in the front window informing people of their application. There are no notices on the side of the property in Vernon Street and no residents nearby have been informed. I only found out about the application after a telephone call from a gentleman at the council today after I questioned if the cafe had planning permission for their outside area.

I strongly oppose the application and I question if local residents have been informed enough and if they can be given more time to oppose the licence?
